Order :

1. Gujarat State Road Development Corporation, Gandhinagar (herein after referred to as GSRDC) had entered into a Concession Agreement with M.S.Khurana Infrastructure and Toll Road Pvt. Ltd. (hereinafter referred to as “the Concessionaire”) on 23rd Nov 2005 for development improvement and widening of Km. 5/2 to 50/0 of Bhuj-Nakhatrana road (Project Highway) on BOT Basis. The Concessionaire have agreed to develop, design, engineer, procure, finance, construct, manage, operate & maintain the Project Highway throughout the Concession Period in accordance with the provisions of the Concession Agreement.
2. Under article III of the Concession Agreement, the project is vested in the Concessionaire for the Concession Period as defined in the article 3.1 of the Concession Agreement.
3. Now in recognition of the Developer’s rights under the Concession Agreement, the Government of Gujarat hereby confirms, declares and orders that a charge shall be determined, levied, collected, retained and appropriated in accordance with the Concession Agreement by the Concessionaire or their authorized agent/ servants on motor vehicles of the classes and trailers drawn by such vehicle specified in column no. 2 at the rate specified against each of them in column no.3 of the schedule of charges hereunder.

The fee shall be levied on vehicles using the road (as defined in the Concession Agreement) and entering toll plaza and passing over the project highway with effect **from 6.00 AM on 05/04/2018** till further notice.

4. The following types of vehicles are exempted from paying the fee specified in the above schedule.

Vehicles having VIP symbols which officially belong to the President of India, the Vice President of India, the Prime Minister of India, Governor of States, Lt. Governors of Union Territories, Chief Ministers, Central and State Ministers, Presiding Officers of Central and State legislatures having jurisdiction, judges of the Supreme Court of India and of the High Courts having jurisdiction, Foreign Dignitaries on State visit to India, Heads of Foreign Missions stationed in India using cars with CD symbol. Members of Parliament. Members of Legislative Assembly, Central and State Government Vehicles, Officers of GSRDC. persons required to use the Project Highway for discharging their statutory obligations in relation to the Site. Independent Consultant, Central and State forces in uniform including armed forces, para military forces and Defense vehicles, Police vehicles, winners of the Gallantry Awards namely, Param Vir Chakra, Ashok Chakra, Maha Vir Chakra, Kirti Chakra, Vir Chakra and Shaurya Chakra on production of ID cards authenticating the award by the competent authority, Members of District Panchayat & Taluka Panchayat, Emergency Vehicles such as Fire fighting vehicles, Ambulances and vehicles used during rescue operation in emergency.

5. The Concessionaire is entitled to regulate or prohibit the use of Road by the user unless fees, as notified, are duly paid by the user for the use of the Road.
6. When a vehicle has to use the Project Highway more than once in a day, the user at his option be entitled to do so on the payment of one and half times the Fee for one way trip in the first trip itself. A vehicle owner shall also be entitled to a monthly pass on payment of Fee equal to thirty times the Fee for one-way and entitled to use the Project Highway for unlimited time during the tenure of monthly pass.
7. Local Commercial Traffic * and Local Personal Traffic ** as described in the agreement shall pay users fee of 50% of the applicable fees.”
8. The employees appointed by the Concessionaire or its agents/ servants are authorized to collect the fee and issue a receipt thereof.

* **“Local Commercial Traffic”** means any commercial vehicle including buses, trucks, light motor vehicles or taxis engaged in carrying goods and passengers and required to use the project highway frequently and owner of vehicle resides within distance of 2 Km. of toll plaza and registered with the Concessionaire and as may be certified by officer nominated by the GSRDC.

** **“Local Personal Traffic”** means and includes a personal vehicle which is registered with the Concessionaire by any person who normally resides or works at a place that can normally be approached only by using a part of the Project Highway and such person is,

therefore, required to use such vehicle for commuting daily on a part of the Project Highway, and as may be certified by any officer nominated by the GSRDC.
